CHAIRMAN'S ANNUAL REPORT

Yet another year has passed by and it brings me great pleasure to be able to give you a brief summary of the last twelve months in the life of Hethersgill Parish Council.

As you were aware in May 2015, we successfully re-elected seven Councillors which left us with two vacancies. I am pleased to report that both vacancies were filled promptly and our Council is again working at full capacity. All of our Councillors work hard on your behalf and are very happy to listen to any concerns you have. Our contact details are always printed in each edition of The Gill so please don't hesitate to get in touch if you wish to raise anything with us.

We have been doing some tidying up works around the Parish this year. Most of you will hopefully by now have noticed the two new noticeboards at Kirklinton and Uppertown. These boards were fully paid for by the Cumbria County Council Community Grants fund and we hope you will agree that they are a welcome addition. The old boards, although sturdy, were subject to all the inclement weathers and more often than not, the notices were blown down causing a litter nuisance, so we hope these new boards will prevent such problems. We have donated the two old boards to local community groups who can put them to better use.

I am also pleased to report that we have spent a bit of time keeping the Sand Hole Common Land in better shape. This small piece of community land has had regular grass cuts to try and keep the area more visitor friendly.

We were very pleased to see the implementation of the 30mph speed restrictions around the Crossroads. The process leading to this speed reduction was begun by members of our parish raising complaints about the perceived speeds being met in that area, so shows what we can achieve when you alert us to problems you are having.

Many of you have been affected by the numerous road works we have had throughout the Parish. We are aware that our roads are not in the best of states and we continue to report defects when we become aware of them. We would urge you as the public to also report any problems to the Highways Hotline.

As well as reporting Highways defects, we do work closely also with the Footpath and Rights of Way Officer. If you do know of any problems affecting our footpaths we can speak to him and have maintenance works discussed or action taken on blockages on the routes.

In the last Annual Report I mentioned that we were trying to get the volunteer bus service to operate in our Parish. I am pleased to report that the bus service - the Border Rambler - is operating between Carlisle and Brampton very successfully and will be undertaking research soon in Hethersgill to see if the service can be extended here.

I also continue to work on the Life+ Project to restore Bolton Fell to try and ensure that the local community is informed and involved. Many of you did attend the Open Days that the BogLife team held at the Moss. We will try and keep you updated of any relevant future developments with this long term restoration project.

We held some first aid training last year which was well attended. Thankfully our defibrillator has not needed to be used but remains at the Hall for emergencies. We have put up some signs recently to help guide non-locals to its location.

Planning matters have once again been quiet with five applications coming to us this year for our comments. We do discuss all planning

matters at our meetings and have a set of the plans to view so come along if any applications are causing you concern.

Financially I am pleased to report that the Council have not increased their precept this year. This was a difficult decision as one of our main funding streams has been abolished so we have lost a substantial proportion of our income. We are comfortable that with careful budgeting we can continue to provide the same levels of service as before. This year we have been pleased to have supported the Parish Hall again as their ongoing refurbishment continues. We once again also made our regular donations to the Social Committee, the PCC and the Great North Air Ambulance. In addition, we were pleased to also help support the above mentioned bus service and the Blood Bikes charity, who do great work in our area.

One area of concern that we have as a Parish Council is a constant clash of dates with district Council meetings. This has prevented our City and County Councillors being able to attend over the past year. There is some information in the newsletter with the plans we have in place to try and solve this problem. I do offer them thanks though for their continued support via email and telephone!

Looking forward into 2016/17 we continue to make plans as to how we can help you. Broadband, as ever, is a priority and we have a small project budget for additional plans that are still being formulated. If you have any ideas we would be happy to listen to them.

In conclusion, I would like to offer thanks to our Parish Councillors and Clerk for their contributions and hard work.

BORDER RAMBLER BUS SERVICE

The Border Rambler is proposing to commence a Thursday service through the following villages from



the beginning of September and needs your help and feedback to assess the service viability. The Service will run through Lanercost, Walton, Hethersgill, Smithfield, Scaleby and Houghton Hall to Carlisle. All eligible passengers will be able to use NoW Card concessionary travel.

Please leave your contact details and let us know if you would plan to use the bus service occasionally or frequently. We will get back to you to discuss our plans. Border Rambler have been running since September 2015 through the flooding and adverse weather this winter, we have never missed a service day yet and have carried over 1000 passengers.
