CHAIRMAN'S ANNUAL REPORT

Once again, I find myself amazed that another twelve months has passed by and I'm in a position that I am writing another summary of our Council activities over the last year.

Our maintenance works continue in the Parish and have been a prevalent feature in 2016/17. Items at the crossroads have been our biggest issue with some disappearing for repair. Firstly, the fingerpost suffered significant damage and we had this sent away for expert repair. Thanks go to City Councillor D Shepherd for fully funding this for us. The eagle eyed of you will have noticed our noticeboard at the crossroads also temporarily disappeared. Again, this has been out for much needed maintenance works. We were consulted over the removal of the BT telephone box also at the crossroads; however, we have had no news as to whether this may be retained!

Further maintenance works were also necessary to our defibrillator. We had to temporarily send it away for repair, although we did obtain a replacement machine during the time it was being fixed. Finally, we also continue to maintain the grass at the Sand Hole to keep this area tidy and (hopefully) free from fly tipping problems.

The provision of superfast broadband remains on our agenda. Although our cabinet is now switched on, we are well aware that problems remain and that the majority of our residents struggle to achieve a satisfactory service. We do have Councillors working on this issue so get in touch if we can help.

Highways issues remain widespread. There is a new reporting system for highways issues that can be used to report defects online. Please do use this service or get in touch with us and we will report any problems that occur. The Council was pleased to support a petition submitted to us regarding perceived speeding at the Hallfoot Mill area. We were able to get the traffic team at Highways to undertake some speed measurement in the region and following this new signage will be installed during 2017.

Planning applications remain quiet with 7 coming to the Council this year. We do have a set of plans for new applications at our meetings, so do come along with any concerns you have about planning matters in our area.

The Border Rambler volunteer bus service continues to operate within our parish - please use this service to ensure it remains viable.

Onto financial matters, the Council agreed to keep the level of precept at the same level for a further year. We have made significant donations to the Parish Hall this year and plan to do so again during 2017/18 to support them in their refurbishment works. We have also once again made our regular donations to the Social Committee, the Parochial Church Council and the Great North Air Ambulance.

Our nine Councillors continue to work hard for our parish on your behalf. All Councillors attended a training course in 2016 so that we remain up to date with current trends and legislation. Thanks are offered to each of them for their service to our parish. Moving our meeting to the third Tuesday of every other month has helped our City and County Councillors to attend more frequently and we thank them for their support. Finally, thanks are offered to the Clerk for her continuing efficient administration and support.

QUEEN'S AWARD FOR VOLUNTARY SERVICE

Do you know a voluntary group who deserves to be recognised? The Queen's Award for Voluntary Service is an annual award made to recognise and reward the most exceptional and innovative groups who provide voluntary led activities carried out by groups in the community. It is a highly competitive and prestigious award where by only around 50% of the nominees go on to win.

Any group of 2 or more people doing outstanding volunteering work can be nominated for the award. The majority of the group must be volunteers, and more than half the volunteers must have the right to live in the UK. The groups should also have been running for 3 years or more to be eligible.

To be nominated for the 2018 award, the group should:

- Provide and meet a need for people living in the local community
- Be supported, recognised and respected by the local community and the people who benefit from it
- Be run locally

Winners receive a certificate signed by the Queen and a domed glass crystal. Representatives from the group may also be invited to attend a royal garden party. Nominations received by the 15th September 2017 will be considered for the 2018 award. Together we can help groups to be recognised and rewarded for their remarkable voluntary work.

Hallburn Wind Farm Community Benefit Fund **May 201**

About the fund:

REG

The Hallburn Wind Farm is committed to providing a community benefit fund of £66,000 per year for community projects. The Fund will be split equally over two funding rounds each year, and groups can apply for grants between £250 and £20,000.

The closing date for the first round of applications is **6** September 2017. Decisions will be made by late October. The second closing date for applications will be **14** February 2018.

Project locations:

Projects for which grants are requested must be located within the Parishes of Kirkandrews-on-Esk, Arthuret, Hethersgill, Kirklinton Middle and Westlinton.

Project purpose:

The Fund is open to **any** community project which is for the benefit of residents of the local area. This Fund can provide both capital and revenue grants.

Eligible Organisations:

Eligible Organisations, who can apply for funding include:

- Voluntary and community groups
- Parish Councils
- Schools and educational establishments (for projects above LEA responsibility)
- Social enterprises (including credit unions, co-operatives, social firms, community owned enterprises, community interest companies and development trusts) provided they operate on a not-for-profit basis.

Applicants need to have a written constitution, a set of rules, or a governing document and will need to have a bank or building society account with a minimum of two signatories in place before applying for a grant.
