CHAIRMAN'S ANNUAL REPORT

When I took over as Chair in May 2019, I did not anticipate the circumstances in which I would be writing this, my first annual report, to you. These strange and unprecedented times were certainly not what I planned on having to discuss with you all in our parish newsletter - although it does make a change from the weather or Brexit!

I should firstly begin by expressing thanks to Harry Kay, who retired as Chairman and Parish Councillor at our last set of elections. Harry was a brilliant leader and his local knowledge and sense of humour are missed at our meetings.

The Council were having quite a productive year with a number of ongoing projects that we were working on. We had two events planned for you, including a spectacular VE Day commemoration in conjunction with the Social Committee, and then of course, COVID arrived and derailed all our plans. We were also working on a "Welcome to Hethersgill" pack which we intend to distribute to new residents but the launch of that also had to be postponed.

The Council meeting in March was cancelled as a result along with our Annual Parish Meeting and Annual Meeting of the Parish Council, however, since May we have been meeting online using Zoom. Meetings are certainly different, and we do all miss being able to meet up for them, but we have adapted and are now all quite comfortable with the virtual arrangements. The agenda and papers for the meetings are always published on our website and you as the public are more than welcome to join in. During this pandemic we are not updating our parish noticeboards.

Since the last annual report, we have dealt with thirteen planning applications. Although there has been a longer period than normal between reports, it is a significant increase on the norm.

Highways issues remain one of our most talked about topics. If you do encounter any problems on our roads please do report it to the Highways hotline (either by phone or online).

As with many other projects during COVID, broadband issues have quietened down but we are delighted to hear that measures are progressing in the area to improve both phone line quality and internet speeds.

In November 2019, a decision was taken to retain the same level of precept. We will be debating the level of the precept for 2021/22 at our November meeting and we do recognise the financial strain that many are under so will be making our decision with this borne upmost in mind. We remain fortunate to be able to access Hallburn Windfarm Grants and urge any local eligible groups to do the same.

We do still have two vacancies for new members on the Council and will look at filling these by co-option once we begin meeting again in person. We did hope to be able to get together in 2020 but, at the time of writing with the virus increasing in prevalence, it is unlikely that in-person meetings will resume much before May 2021. We, as a Council, do however remain available to listen to any concerns or problems you have an would urge you to keep in touch so that we can assist you. With that in mind, there is a questionnaire enclosed with this Gill. Full details are provided for you and I would urge you to complete it and return it to us so that we can be best placed for continuing to help you in our small community.

Hopefully in 2021 we will be able to return to some sense of a new normal and we do hope to be able to put our VE day celebrations on for you too.

Finally, I would like to offer my thanks to each of the parish councillors and our City and County ward members for their continued support. Thanks also to our Clerk for her assistance in keeping our meeting schedule on track and all her hard work for the council – particularly during this difficult year.
